

& Railways have not cleared the file till date. (Action: Asst. General Manager Dhemaji, Silapathar APDCL).

4. PWD (Rural Roads):

The Ex. Engineer informed the house that the plan and Estimate have been prepared for the mud road that connects newly Constructed FCI depot at Archi pather and NH 515. Chair directed Ex. Engineer to submit the plan and estimate for the said road through Deputy Commissioner Office. (Action: Ex. Engineer).

5. PWD (NH):

The AEE (NH) apprised the house that bituminous layer works at Somorajan portion of the NH is on full speed. Chair pointed the AEE about the potholes in the national highways within district. AEE apprised that the repairing works will be started shortly. (Action: PWD NH).

6. DTO:

The DTO Dhemaji apprised the house that the E Ricksha Registration in the district is on except chinese made assembled E ricksha & Town committee Registered E Ricksha. Chair directed DTO to ban the shops that deal with the assembled E rickshaw in the District. (Action: DTO Dhemaji).

7. WATER RESOURCE DEPARTMENT:

The Chair directed Ex. Engineer to cooperate with the AG audit team. Regarding the Burisuti breach at Jonai subdivision, Chair asked Executive engineer to discuss the matter with PD DRDA, so that work can be completed under MGNREGA. (Action: Ex. Engineer, Water Resource Dept.)

The Chair asked Ex. Engineer PWD (B) about the time span for completion of the construction work of Dhemaji engineering college. The Ex. Engineer PWD (B) informed that the construction works of Dhemaji Engineering College will be completed within April 2019. The Chair directed Ex. Engineer to prepare plan and estimate for renovation of Dhemaji Town hall including Toilets, Sound systems etc. Ex. Engineer also informed the house that the Polytechnique at Siman chapori is about to complete. (Action: Ex. Engineer PWD (B)).

9. Veterinary Department:

The Chair directed DVO to act as a Nodal agency to provide facilities to the beneficiaries when the Dairy department official is not available in the district. Chair directed NABARD DPM to submit the Loan schemes to SDO (c) Jonai so that the facilities can be avail by the Locals of Jonai. In this Regard DPM, NABARD informed the house that loan schemes from 1 lakhs to 7 lakhs is available with 25% and 35% subsidy for General and SC/ST categories respectively. (Action: DVO, Dhemaji)

10. District Social Welfare Office:

The DSWO I/C apprised the house about PM Matritva vandana Yojana and informed that 1177 Nos. of forms uploaded under the scheme with a target of 5000 Nos. for the District. Chair pointed the poor updation of PMMVY forms and directed i/c DSWO to conduct a meeting with Deputy Commissioner along with concerned CDPOs and supervisors and Jt. Director Health services on 8th March 2019. (Action: DSWO i/c, Dhemaji)

11. District sports Office:

The DSO representative apprised the house that the development works of 12 Nos. of school play ground of the district started @ Rupees 20 Lakhs per school. The concerned SMC will monitor the development activities under direct supervision of DSO office, Dhemaji. (Action: DSO, Dhemaji).

12. Miscellaneous:

Chair directed all HoDs to submit detail list of employees including both Head quarter and the field level office to the Deputy Commissioner before 10th March/2019, so that a proper data base of the district employees can be created to rationalized the

requirement and posting of employees by the Deputy Commissioner as per the recommendation of 7th pay commission.

Chair highlighted some important issues raised during the meeting with district Judge. In case of Medico legal case Chair directed Jt. DHS to submit Medical officer Mobile Nos. and email id. Chair directed DTO to look in to the matter of over loading in the highways with Superintendent of Police. Chair also asked DTO to cancel the driving licensed of reckless & high speed driving within the district.

As nos. of schemes under PWD (B) not completed within the district in stipulated time, Chair fixed a special review meeting with PWD (B) Department on 14th March/2019 at 3.00 p.m. Chair directed Ex. Engineer PWD (B) to cancel the work order of the concerned contractor who is responsible for the construction of DC,s quarter, Dhemaji.


Asst Director Town & Country Planning apprised the house about the Construction of Bus terminus in Dhemaji which is to be completed within 31st march, 2019. Chair discussed all important ongoing projects under T&CP like construction of Roads, Dhemaji town protection drainage system etc under T&CP and requested the newly joined Asst. commissioners to submit progress report of the said projects immediately.

Chair asked about the PMAY status in Dhemaji and E.O Dhemaji informed that out of 1468 Nos. of beneficiaries 960 Nos. have completed the work, where 57 Nos. have not started work and not a single house completed in Silapathar under PMAY. Chair asked concerned official to submit report in this regard. Participating the discussion, Town committee Chairman informed the house that the scenario of Tax collection in Dhemaji town has not been not satisfactory.

Chair asked presentation on activities of NULM, NRLM and skill development Mission under Dhemaji district from the respective DPMs.

Chair directed all the line department to contribute 10% of the royalty in to District mineral fund trust of the district and asked ADC (Forest)& DFO to monitor the same.

And last the meeting ended with vote of thanks from the Chair.


