On detection of any irregularity/malpractice by any allottee they must take legal action as per Rules against the offenders as well as to submit their weekly verification/performance report timely and regularly to the undersigned.
12. The Secretary of all GPSS Ltd./FPS Dealers Dhemaji District. They are directed to deposit the required cost price through Bank Draft @Rs.565/- per qntl. to the Area Manager, FCI, Lakhimpur immediately and arrange lifting of the allotted quantity of rice under the above scheme and submit arrival report to the same. Proper books of account shall be maintained against lifting and distribution as done in case of PDS/TPDS items. After lifting of rice they must issue rice to their concerned Agents/FPS dealers at Sub-wholesale approved rate only so that the agents concerned can issue rice to the cards holders at BPL rate per kg. @ 5.566 kg. per card holder.
