**Functions and Responsibilities of the Committee.**

**(Vide Govt.No FSA.66/97/Pt/2 Dated 15.09.2006.)**

1. The member Secretary will be responsible for convening the Committee's meetings every month.
2. The Committee will have to sit once in a month i.c from 15<sup>th</sup> to 25<sup>th</sup> of every month.
3. The meetings should be held in centrally located place within the areas of the F.P Shop.
4. The committee will examine allocation, lifting and ensure the availability and supply of each and every TPDS/PDS items as per norms in the respective F.P. Shops and submit minutes, report to the president through member secy.of the GPSS level vigilance and monitoring committee by 30<sup>th</sup> of every month for its necessary action and disposal.
5. The difficulties faced by the FP shop owners in lifting, transporting and distribution of the items be considered.
6. FP shop holders/agents will be answerable to the committee but will not honour any undue request of the individual members.
7. Area officer(member Secy.) will share information with the members of the committee.
8. The FP shop owner should be compelled to hang the list of FI card holders i.e./BPL and AAY beneficiaries lists tagged to the shop.
9. The committee should see that the monthly allotment the PDS items and balance stock are displayed in written in black board or any other suitable way.
10. In case of any malpractice the member secretary as the area officer will take the legal action against FP shop owner within the legal framework.
11. Examine and suggest practical/viable solution to improve the system.
12. Relevant misc. matters.
