



All the Secretary of GPSS Ltd are directed to keep the undelivered stock of BPL rice against those beneficiaries as rolling stock whose Special F.I. Card was not renewed within the Govt. fixed stipulated time until necessary instruction received from the Govt. Last date of depositing value is fixed 15th day of each month.
